### Awards

The opportunity to nominate members for awards is rapidly drawing to a close. The ISSS-TVC is still waiting for submission. Rumor is, there is one submission being worked and hope this gets completed and submitted in time for consideration. There is no limit on how many submissions so please identify a deserving member and have them recognized.

### Fun stuff

The majority of our membership is probably aware there is an upcoming Federal election. Here are some trivia facts related to the United States election that you may or may not be aware of:

- **To what party did George Washington belong when he was elected the first US President in 1789: The Federalists, The Anti-Federalists, or the Democratic-Republicans?**

Neither Washington nor his opponent John Adams were affiliated with any party at the time of the first election in our country's history, probably because they were too busy forming the foundation of our country. In the second election in 1792, both men ran again (with the same results), but by this time, they were both aligned with the Federalist party.

- **Who was the first person to run for and win the position of Vice President?**

George Clinton in 1804. Prior to that year, the Vice President was the Presidential candidate with the second-most electoral votes (John Adams in 1789 and 1792, Thomas Jefferson in 1796, and Aaron Burr in 1800), as outlined in Article II, Section I of the US Constitution.

- **Who received more electoral votes in the 1800 election: Thomas Jefferson or Aaron Burr?**

Aaron Burr. Though Jefferson was ultimately declared the winner, there were multiple abnormalities in the electoral process. Burr originally received 74 electoral votes to Jefferson's 72, but only because one New York elector illegally cast both of his votes for Burr. When this was uncovered, his second vote was redirected to Jefferson, resulting in a tie. But even a tie was not the result that should have been. The Republicans planned for one of their electors to abstain from his second vote in order to give Jefferson a one vote advantage, but the plan was botched, resulting in a tie. This tie was settled by a vote of the outgoing House of Representatives, in which Jefferson emerged victorious

- **Who was the only candidate to receive electoral votes after death? 1872**
- Liberal Republican candidate Horace Greeley. Incumbent President Ulysses S. Grant won by a landslide (286 electoral vote to 66), but Greeley passed away between the popular vote and the voting in the Electoral College. In the confusion that followed, Greeley's electors split their votes among 4 different candidates, with Greeley still getting the votes of 3 electors. Congress subsequently disallowed these 3 votes for obvious reasons, namely Greeley's lack of a pulse, but Greeley still goes down as the only candidate to die during the electoral process.

- **Who was the only candidate to receive an absolute majority of the popular vote while still losing the election?**

Many of you will think the answer is Al Gore in the 2000 election, but Gore only received a relative majority with 48.4% of the popular vote to George W. Bush's 47.9%. The only losing candidate to receive more than 50% of the popular vote was Democrat Samuel J. Tilden in 1876. Tilden led Republican Rutherford B. Hayes in the Electoral College 184-165 with 20 votes still in dispute. Each party claimed it had won the 19 votes belonging to Florida, Louisiana, and South Carolina while one of the three voters

from Oregon attempted to vote for Tilden before being overruled by the state's other two electors. After much legal action, the Democrats agreed to allow all 20 disputed votes to go to Hayes in exchange for the withdrawal of federal troops from the South, ending Reconstruction, and multiple other compromises.

- **Who was the last third-party candidate to win electoral votes?** Independent George Wallace in 1968. A big political issue at the time was the government's involvement in the segregation of schools in the South. Wallace ran on a platform opposing such federal intervention, and therefore won the southern states of Alabama, Arkansas, Georgia, Louisiana, and Mississippi who supported segregation.
- **Which election featured the most lopsided vote in US history?** In 1984, incumbent President Ronald Reagan broke every election record imaginable in his race against Democratic candidate Walter Mondale who received only 13 electoral votes from the District of Columbia and his native Minnesota. Reagan received almost 60% of the popular vote, defeating Mondale by almost 17 million votes and garnering a record 525 electoral votes from 49 states.
